Grandma Etta's Fruit Preserves

NOTE: PARENTS NEED TO ASSIST AS THIS REQUIRES COOKING

Ingredients

- 2 cups fresh strawberries, crushed
- 4 cups sugar
- 1 (1.75 ounce) package dry pectin
- 3/4 cup water

Directions

1. Mix crushed strawberries with sugar and let stand for 10 minutes. Meanwhile, stir the pectin into the water in a small saucepan. Bring to a boil over medium-high heat and boil for 1 minute, stirring constantly.
2. Stir the boiling water into the strawberries. Allow to stand for 3 minutes before pouring into jars or other freezer storage containers.
3. Place tops on the containers and cool to room temperature for 24 hours.
4. Place into freezer and store frozen until ready to use.
5. Thaw in refrigerator

Prep time: 10 minutes

Cooking time: 5 minutes

Ingredients

- 1 cup vanilla yogurt
- 1/2 cup peanut butter
- 1/2 cup whipped topping

Directions

1. In a bowl, combine the yogurt and peanut butter.
2. Mix well.
3. Fold in the whipped topping.
4. Refrigerate until serving. Serve with sliced apples. Refrigerate leftovers.

Ingredients

- 1 8-ounce package cream cheese, softened
- 1 7-ounce jar marshmallow creme
- 1 tablespoon lime juice

Directions:

1. In a mixing bowl, combine the cream cheese, marshmallow creme, and lime juice.
2. Mix the ingredients until smooth. Serve with fresh sliced fruit. Refrigerate leftovers.

Ingredients
